### **Corruption of the WHO by Gates**

BMGF worked at exercising extraordinary powers over the WHO, in 2016, by promising grand donations...in return for having as much "say" on WHO affairs, as any WHO member-state.

It is under his direction that a world-wide WHO Pandemic Treaty has been proposed, whereby the WHO Director-General has the power to declare "Pandemics" & assume control of the Ministries of Health in all member-states. In November 2022, amendments to the 2005 International Health Regulations (IHR) were proposed.

### **Psychology .**

"**Mass-Formation Psychosis**" is the term used in 2021, by Prof.Mattias Desmet, Clinical Psychologist at Ghent University, to describe a storm of international fear for this man-made disease, known as SARS-Cov-2.

"Desmet deconstructs the societal conditions that allow this collective psychosis to take hold. By looking at our current situation and identifying the phenomenon of "mass formation"—a type of collective hypnosis—he clearly illustrates how close we are to surrendering to totalitarian regimes.

With detailed analyses, examples, and results from years of research, Desmet lays out the steps that lead toward mass formation, including:

- An overall sense of loneliness and lack of social connections and bonds
- A lack of meaning—unsatisfying "bullsh\*t jobs" that don't offer purpose
- Free-floating anxiety and discontent that arise from loneliness and lack of meaning
- Manifestation of frustration and aggression, from anxiety
- Emergence of a consistent narrative from government officials, mass media, etc., that exploits and channels frustration and anxiety"

"The Johns Hopkins Center for Health Security in partnership with the World Economic Forum and the Bill and Melinda Gates Foundation hosted Event 201, a high-level pandemic exercise on October 18, 2019, in New York, NY. The exercise illustrated areas where public/private partnerships will be necessary during the response to a severe pandemic in order to diminish large-scale economic and societal consequences." Plenty to see.

It is interesting to see how this was held barely 2 months before the WHO Director-General began sounding off about an unknown disease spreading in China & reaching pandemic levels. Then how it was isolated to the "wet market" in Wuhan, where traders handled all sorts of caged, probably diseased, "wild" animals. How coincidental that :

- 1 of China's Bio-Security labs is located in Wuhan.
- US NIAID Director DrFauci <https://www.niaid.nih.gov/about/anthony-s-fauci-md-bio> happened to have arranged that "gain-of-function" research into Corona-viruses be conducted at the Wuhan Lab, in years prior.
- There was no discussion at Event 201 about actually tackling the disease, merely about controlling the narratives around it.

We are in an Information War, because the primary weapon is information, and whoever gets to define reality with their narrative, wins.

During Covid, we experienced a radical shift in our social contract with The State. Before the pandemic, the social contract, the generally accepted modus operandi, was that everyone had the right to bodily autonomy. While it's good to donate blood, for example, we are not required to do so — even if someone's life hangs in the balance.

If someone is vulnerable to illness due to pre-existing conditions, that person has always been expected to take their own precautions. If one has a peanut allergy, one makes sure not to eat anything with peanuts, for example, but others are not mandated nor required, to accommodate those who are vulnerable.

What we have never done is make other people responsible for our comorbidities and pre-existing conditions and force them to submit to some medical intervention that could harm or kill them, in order to improve our chances of survival.

If The State is going to tell us that we must get vaccinated because it is our duty to protect other people, then that is a very deep and radical shift of our social contract. It should require serious public dialogue followed by a democratic



mandate.

We were told that we must surrender our bodily autonomy for the common good. If we disagreed, we were simply ostracised; removed from our job; quite possibly threatened by "the vaccinated".

This new social contract, sprung on us during the COVID crisis, is actually part and parcel of The WEF's "Great Reset".

"World-renowned economist Klaus Schwab, Founder and Executive Chairman of the World Economic Forum, explains that we have an opportunity to shape the fourth industrial revolution, which will fundamentally alter how we live and work.



Schwab argues that this revolution is different in scale, scope and complexity from any that have come before. Characterized by a range of new technologies that are fusing the physical, digital and biological worlds, the developments are affecting all disciplines, economies, industries and governments, and even challenging ideas about what it means to be human."

**What does he mean?** Humans are hackable animals. Once they, the WEF overlords, have implanted electrodes somewhere in human bodies or attached wearables, the recipients can be instructed & monitored, whilst carrying out the tasks put out for them by their "owners".

Whilst the length of the video is unchanged, the confronting sections have been replaced with the sitdown interview between Harari & the lady host who had introduced him.

In the original version, he was very blunt. He moved to "humans are hackable animals", showing his formulae for Hackability, then describing some of humanity as "the Useless eaters".

He described the creation of 3 types of people :  
The Un-Exploited; the Exploited & the Irrelevant.  
These latter will slowly be pushed off the page.

Exploited & Irrelevant will ultimately become slaves to the Un-Exploited. They will have some kind of implant, connected to the AI computer, which will "read" their daily mood & level of compliance...for duties. If their mood appears outside of expectations, possibly in disagreement with their lot as slaves, they can be immediately consigned to "the Gulag" (referring to Solzhenitsyn's Gulag Archipelago in Russia...termination actually)  
There will be no space for "passengers". He is prolific on YouTube.

**Who exactly are their Exploited then, we may ask?**

Government employees, Essential Services, just about anybody with viable education, who is not one of the perceived Elite Un-Exploited.  
The sort of people who were targetted, without the slightest consideration, for Covid-19 Infection or Injection or both.
